Fees/Fundraising/Financial Policy

Genesee Valley Bills Youth Football and Cheerleading is a volunteer, nonprofit organization. There are no paid positions within the organization. Numerous expenses are incurred to operate the GVB program year-to-year. In order for your child(ren) to have such a program in which to participate, there are expenses all participants must share throughout the year/season. This policy acknowledgement and fundraising agreement **MUST** be completed, signed, and returned to the GVB Treasurer as part of each participant's registration. All information will be kept confidential.

REGISTRATION FEE: This is a one-time fee of \$30.00 (one child) or \$50.00 (multiple participants from the same family). This fee is due at registration and is non-refundable and is considered a donation to the program. The only exception to this policy is if a child is found by a doctor to be medically unfit to participate in the organization.

NO REFUNDS WILL BE ISSUED AFTER THE FIRST WEEK OF PRACTICE

If this proves to be a financial hardship, you must complete a GVB financial hardship form and submit to the GVB Treasurer to be considered for an alternative arrangement/payment plan.

PARENT PARTICIPATION/EQUIPMENT/FUNDRAISING FEE

This is a one-time fee of \$50.00 per family, due at the time of registration. The purpose of the fee is to cover the parent participation deposit, the equipment deposit, and the fundraising deposit.

PARENT PARTICIPATION: Parents/guardians are required to complete at least two assigned volunteer positions *per participant* (required number of positions may vary season-to-season, depending on requirements). All parents/guardians will be given their first opportunity to sign-up for their preferred volunteer assignments prior to the start of the season. Game day chores include (but are not limited to) the following: concession stand, sideline chains, pre-game set-up, sideline monitors, game video, post-game clean-up, selling 50/50 raffle, and cheer competition assignments.

UNIFORM/EQUIPMENT: All GVB owned equipment must be returned to the organization in good, clean condition on the equipment turn in date at the end of the season. If you fail to return GVB equipment in good, clean condition by December 1st of the present year, you will be charged the cost to repair, clean, or replace the equipment. Failure to pay the fine will result in legal action to recoup the cost of cleaning, repairing or replacing the equipment plus any legal fees GVB incurs to recoup said fees.

FUNDRAISING: Fundraisers provide the bulk of the monies needed to purchase equipment, uniforms, insurance, league fees, and team activities. As a participant in this program, **EACH CHILD** must fulfill the **MANDATORY** fundraising requirements each season.

Each participant may be asked to actively participate in up to three fundraisers designated by the GVB Board of Directors as they are handed out throughout the year. An individual child must raise a minimum of \$125 profit/ while a family with more than one child participating must raise a minimum of \$250 profit from completion of said fundraisers.

If you complete the required parent participation duties, return all uniforms/equipment in satisfactory condition, and complete the mandatory fundraising activities, the \$50 fee will be returned to you at the end of the season. Checks are usually prepared for you to receive at equipment return. No partial refunds will be given.

RETURNED CHECKS: Although this organization does not charge a fee for any returned/insufficient funds checks, we reserve the right to recover the original amount of the check plus any bank fees we incur. The proper legal steps will be taken including notification to the applicable law enforcement agencies when necessary.

COMMUNITY YOUTH FOOTBALL LEAGUE ZERO TOLERANCE POLICY

In an effort to make youth football and youth cheerleading a more desirable and rewarding experience for all participants, the Community Youth Football League Board of Directors have instructed the participating local boards to adhere to certain points of emphasis relating to sportsmanship. This policy is designed to require all players, cheerleaders, coaches, helpers, officials, board members, administrators, parents and spectators to maintain a sportsmanlike and educational atmosphere before, during and after all CYFL functions (games, practices, competitions, etc.). Thus, the following points of emphasis will be implemented:

PLAYERS / CHEERLEADERS

During GVB/CYFL functions (games, practices, competitions, etc.), an Official, Coach, or GVB Representative will assess a Zero Tolerance un-sportsmanlike penalty whenever a player or cheerleader:

1. Openly disputes or argues any decision by an official or judge.
 2. Uses obscene or vulgar language at any time, even if it is not directed at a particular person.
 3. Visually demonstrates any sign of dissatisfaction with any official / judges decision.
- ❖ *Any time that a player or cheerleader persists in any of these actions, a game disqualification will be assessed and the appropriate paperwork will be submitted to the league president for further action.*

COACHES

During GVB/CYFL functions (games, practices, competitions, etc.), an Official, Coach, or GVB Representative will assess a Zero Tolerance un-sportsmanlike penalty whenever a coach:

1. Openly disputes or argues any decision by an official or judge.
 2. Uses obscene or vulgar language in a boisterous manner to anyone at any time.
 3. Visually demonstrates any sign of dissatisfaction with any official / judges decision, including intent to incite the officials, players or spectators.
- ❖ *Any time that coach persists in these actions, a game disqualification will be assessed.*

OFFICIALS

Officials are required to conduct themselves in a business like, sportsmanlike, impartial and constructive manner at all times. The actions of officials must be above reproach. Actions such as baiting or inciting players or coaches are strictly prohibited.

On field officials are ambassadors of the game and must always conduct themselves with this responsibility in mind.

PARENTS / SPECTATORS

Parents / spectators will display appropriate behavior at all times. When parents / spectators display inappropriate and disruptive behavior that interferes with other spectators or the GVB function (games, practices, competitions, etc.), the function will be stopped for the purpose of removing the offender(s) from the area. Once removed, play will resume. Lost time will not be replaced and violators may be subject to further disciplinary action by the local governing board. This inappropriate and disruptive behavior shall include:

1. Use of obscene or vulgar language in a boisterous manner to anyone at any time.
2. Taunting of players, cheerleaders, coaches, officials or other spectators by means of baiting, ridiculing, threat of physical violence or physical violence.
3. Throwing of any object in the spectators viewing area, sidelines or playing field, directed in any manner as to create a safety hazard.

Community Youth Football League (CYFL) Social Media Code of Conduct

Purpose

The purpose of the CYFL Social Media Code of Conduct is to provide rules for the use of social media. Social media refers to any online tools or functions that allow people to communicate and/or share content via the internet.

This social media policy applies to platforms including, but not limited to:

- Social networking sites (e.g. Facebook, Twitter, LinkedIn, Google+, Pinterest, Yammer, etc)
- Video and photo sharing websites or apps (e.g. YouTube, Vimeo, Instagram, Flickr, Vine, etc)
- Blogs and micro-blogging platforms (e.g. Tumblr, Wordpress, Blogger, etc)
- Review sites (e.g. Yelp, Urban Spoon, etc)
- Live broadcasting apps (e.g. Periscope, Meerkat, Facebook Mentions, etc)
- Podcasting (e.g. iTunes, Stitcher, Sound cloud, etc)
- Geo-spatial tagging (e.g. Foursquare, etc)
- Online encyclopedias (e.g. Wikipedia, etc)
- Instant messaging (e.g. SMS, Skype, Snapchat, WhatsApp, Viber, etc)
- Online multiplayer gaming platforms (e.g. World of Warcraft, Second life, Xbox Live, etc)
- Online voting or polls
- Public and private online forums and discussion boards
- Any other online technologies that allow individual users to upload and share content.

This Code of Conduct applies to all members of the CYFL, including participants, coaches, volunteers, board members, and parents. It relates specifically to the use of social media to make comment in a context that is identifiable as being in relation to CYFL or any of its member towns. This includes comments or implied comments regarding:

- Games, Competitions, or other CYFL events
- Team or participant performance
- Individuals with a direct context or mention of their role with CYFL, such as officials, coaches, and board members.

Use of Social Media:

Social media is no different than a live microphone. What you post will be broadcast across a wide audience and therefore you must be mindful of how your comments will be interpreted by more than just your closest friends. You must be prepared for your posts to be seen by the persons you are referring to- participants, coaches, parents, officials, and board members.

CYFL Social Media - Code of Conduct:

- All comments, notes, photos, and videos posted on social media sites in relation to the CYFL and its members are to be constructive or positive in their nature.
- Do not post material that is vulgar, obscene, defamatory, threatening, harassing, discriminatory or hateful
- Be respectful at all times on social media. You are expected to show the same respect and regard for people that you would when competing, coaching, officiating, or attending a CYFL event
- Do not use social media to be critical of participants, coaches, officials, administrators, volunteers or spectators. Negative comments and images, bullying, criticism and sexist remarks can be dangerous and harmful to people's wellbeing and reputation and the image of individuals and CYFL.
- Always assume the person you are talking or writing about will see what has been said or written. Ensure all comments are factually correct.
- Use social media as a positive outlet to promote participants, teams, towns and others involved in youth football and cheer.
- Do not tolerate or condone poor social media behavior or actions. If you are aware of or observe poor social media behavior or actions, do not accept it. There is no place for it in youth sports and it will not be condoned. You should remind people of their responsibilities when using social media and warn that action can be taken against them.
- If you believe the breach is serious, report it to the GVB Board of Directors or the CYFL Executive Committee.

Consequences

Your actions on social media may have serious consequences. Negative comments and images, bullying, criticism and sexist or derogatory remarks not only impact negatively on the people they are about, they reflect badly on yourself, your organization, and the people you represent. If you are found to have acted improperly on social media by breaching any of the CYFL Social Media Code of Conduct, disciplinary action may be imposed such as suspension or deregistration from the CYFL.
